CRESTON'S CENTENNIAL CELEBRATING 100 YEARS



Commercial Vending

Commercial Vending, such as food trucks, is now permitted within a specific area of Market Park. Vendors are required to have a valid Business Licence and Commercial 3. Vending Permit. Fees have been updated to reflect services provided at Market Park, such as power. Permits are now available for up to six months. 4.

Please note: Commercial vendor locations are on a first-come first-serve basis. In general, vendor hours are limited to park hours. No overnight parking is permitted.

Fences

Did you know that the Town of Creston has new Fence and Screening regulations? Our Zoning Bylaw includes the types of fence materials you can use, maximum fence height, and requirements around swimming pools. Check out our Zoning Bylaw at **creston.ca** for more information.

Check-in with the staff at Town Hall before you build your fence and be sure to check your property title for any restrictions. It is highly recommended that you have your property surveyed to know where your property lines are before constructing a fence.



Park Bookings

Recent changes have been made to the park booking process. Some key changes are:

- The majority of bookings can be approved by Town Staff, streamlining the approval process. Bookings over 500 people, or serving liquor still require Council approval.
- Capacity for Millennium Park has increased from 150 to 250. Anything larger than 250 will need special approval.
- Closed bookings are now allowed in several parks and public spaces throughout Creston.
- 4. For small events, such as a kid's birthday party, a time slot must be chosen to allow for multiple bookings throughout the day. All set up and take down needs to be completed within the time slot.
- Closed bookings must be 'community orientated'. For example, a community orientated event could be a concert with tickets available for purchase. A wedding would not be considered community orientated.

Sani-dump Closed May Long Weekend



Please be advised that the Municipal Sani-dump located beside Millennium Park will not be available before and during the upcoming May long weekend (May 13-20). This temporary closure is due to the Mid-way setting up in that location for the Blossom Festival weekend.

BC Building Code Update

In March of this year, the BC Building Code underwent notable updates. Among these changes is a requirement for newly permitted homes to include cooling facilities. These facilities must be capable of maintaining indoor air temperatures of no more than 26 degrees Celsius in at least one living space within each dwelling unit.



We'd like to remind the public that the Town of Creston has a Property Maintenance Bylaw in place for the benefit of all residents. This bylaw outlines the responsibilities of property owners to keep their yards and properties in good order and free from any hazards, or unsightly conditions. It is the responsibility of property owners to maintain their property and keep it neat and tidy. This includes, but is not limited to, ensuring that lawns are mowed regularly, garbage and recycling are properly disposed of, and any debris or clutter is removed. Your cooperation in adhering to this bylaw helps to keep our community clean, safe, and attractive for all residents and visitors. Thank you for doing your part!

If you have a concern regarding compliance with one of the Town Bylaws, the Bylaw Compliance Department requires you to fill out a written Bylaw Complaint Form with your name, address, and phone number as well as a detailed description of the alleged bylaw violation. Please note: we do not accept anonymous complaints (no personal information will be divulged).
